UNFINISHED BUSINESS:

The 615 Main Street trailer park issue was discussed. Mayor Rigg updated the City Council on trailers #2 and #3. The trailer park owner, Jone Kent, has hired Jaden McNamara, owner of Jay's Contracting, LLC to demolish and remove trailers #2 and #3. The fourth trailer, which has been red tagged by the city, is owned by Sabrina Slater from Alabama. Ms. Slater has indicated that she does not believe there to be anything wrong with her trailer although she did receive the City Inspector's report. CA Koch advised the City Council they may take action October 6, 2025. A discussion followed. The City Council expressed their appreciation for the trailer park owner, Jone Kent, and her following through with the removal of trailers #2 and #3. Revisions to the nuisance ordinance were discussed. CA Koch will work on a revision.

Nicole Werner joined the meeting at 7:04 p.m.

The former JHS property was next on the agenda. The City is desirous of owning the paved unnamed road that lies along the former football field behind the properties on Division Street from 3rd Street to 5th Street. A discussion followed. CM Boulware stated he has been approached about the driveway behind Division Street from 2nd Street to 3rd Street. The complainant believes the City should buy that section, also, to be fair. Mayor Rigg will discuss this matter with Mr. Tom Johnson. CA Koch advised the City Council if they should buy the property a Resolution would be the best way to handle the purchase.

Ms. Werner asked the City Council what they planned to spend the remainder of the community monies on. Ms. Werner asked the City Council to consider a housing study. A housing study is required when applying for community grants. Ms. Werner stated MRHD has grant money for non-profits and government entities for economic development. Ms. Werner offered to help in any way she could with grant applications.
